

# NOMINATIONS FOR 2020 DEACONS BEING ACCEPTED

Members of the South Tulsa Baptist Church family are asked to prayerfully submit names of those persons whom they feel should serve as deacons. According to our constitution, thirty-nine men will serve on a rotating basis, with each serving a three-year term, not eligible to succeed themselves without a one-year's absence from the deacon fellowship.

The most notable duties of South Tulsa Baptist Church deacons include: a) close contact with prospects and direct ministry to new members in integrating them into the church family; b) serving on the Advisory Council which meets monthly and makes recommendations to the Church; c) serving in a crisis with individual families, staff relationships, and general care of the congregation; and d) serving the Church in its two ordinances, the Lord's Supper and Baptism. Much of what deacons do, including prospect phone calling, Wednesday Fellowship Meal service and ministry to senior adults, is not visible to the entire congregation.

The qualifications for deacons may be found in Acts 6:1-7 and 1 Timothy 3:8-13.
